
This will acknowledge receipt of your correspondence regarding the motion for void judgment that you filed in the Henrico County Circuit Court. You requested that "this Court . . . either file the enclosed Motion for Void Judgment, claiming extrinsic fraud, which can be filed in any court at any time, or Order the Circuit Court of Henrico County to file the action." The jurisdiction of this Court is set forth in Article 6, Section 1 of the Constitution of Virginia:

The Supreme Court shall, by virtue of this Constitution, have original jurisdiction in cases of habeas corpus, mandamus, and prohibition; to consider claims of actual innocence presented by convicted felons in such cases and in such manner as may be provided by the General Assembly; in matters of judicial censure, retirement, and removal under Section 10 of this Article, and to answer questions of state law certified by a court of the United States or the highest appellate court of any other state. All other jurisdiction of the Supreme Court shall be appellate.

To file your motion to vacate in this Court would invoke this Court's original jurisdiction. As you can see from the above, however, a motion to vacate is not one of the items contained within the Court's limited original jurisdiction. If the circuit court considers your motion and the motion is denied, then you would have the right to appeal that decision to this Court.

Further, this Court cannot direct the Henrico County Circuit Court to act based upon your correspondence. You may wish to consult your institutional attorney to discuss your options regarding the motion filed in the circuit court.
