ORDER:

Before the Court are various original proceedings submitted by Mr. Raghubir. In no. 19-15049, Petitioner submitted a document titled "2241 Petition for Writ of Habeas Corpus with Demand for Jury Trial + Admissions + Certiorari." In no. 19-15051, Mr. Raghubir submitted a document titled "<2241> Petition for Writ of Habeas Corpus, Certiorari, Prohibition & Mandamus with Demand for Jury Trial & Admissions." In no. 19-15055, Mr. Raghubir submitted a document titled "<2241> Petition for Writ of Habeas Corpus, Certiorari, & En Banc Rehearing." In no. 19-15190, Mr. Raghubir submitted a document titled "Petition for Writ of Mandamus, <2241>

Petition for Writ of Habeas Corpus + Certiorari.” In no. 19-15191, Mr. Raghubir submitted a document titled “<2241> Petition for Writ of Habeas Corpus & Certiorari w[ith] Demand for Jury Trial and Admissions.”

These documents and others submitted by Mr. Raghubir to this Court seek multiple incompatible and unclear forms of relief. For example, in the document filed in no. 19-15051, the document appears to be titled as a petition for a writ of habeas corpus under 28 U.S.C. § 2241, which must be transferred to the appropriate district court. *See* Fed. R. App. P. 22(a). The same document also appears to be titled as a petition for writ of certiorari, which typically is made to the U.S. Supreme Court. *See, e.g.,* Sup. Ct. R. 10. The same document also appears to be titled as a petition for writ of mandamus or prohibition, which may be made, in some circumstances, to this Court. *See* Fed. R. App. P. 21. Mr. Raghubir’s practice of seeking multiple incompatible forms of relief in a single document has caused confusion in the processing of his cases.

Accordingly, Mr. Raghubir is DIRECTED to submit separate documents to this Court for each form of relief requested from this Court; he may not submit documents identifying multiple forms of relief in a document. For any future document submitted by Mr. Raghubir to the Court in any case (closed, open, or future), if Mr. Raghubir identifies multiple forms of relief, the Clerk’s Office is DIRECTED to process the document only as to the first form of relief identified on the document. This direction does not alter the direction in the Court’s order dated October 18, 2019 in case no. 19-11520, which remains in effect.

The first form of relief identified in four of the five cases before the Court, nos. 19-15049, 19-15051, 19-15055, and 19-15191, is for a § 2241 petition for a writ of habeas corpus. These petitions, under this Court’s rules, must be transferred to the appropriate district court. *See* Fed. R. App. P. 22(a) (“An application for a writ of habeas corpus must be made to the appropriate district court. If made to a circuit judge, the application must be transferred to the appropriate

district court.”). Accordingly, the Court *sua sponte* TRANSFERS these petitions to the United States District Court for the Northern District of Florida.¹ See 28 U.S.C. § 2241(a) (a § 2241 petition must be filed in the “district wherein the restraint complained of is had”). After transferring these petitions, the Clerk’s Office is DIRECTED to close these matters. If Petitioner submits any further original proceeding identified as a petition for a writ of habeas corpus, the Clerk’s Office is DIRECTED, pursuant to Fed. R. App. P. 22(a), to transfer the petition directly to the appropriate district court without further order of this Court.

The first form of relief identified in the remaining case before the Court, no. 19-15190, is for a petition for writ of mandamus. The Clerk’s Office is DIRECTED to process this case as a petition for writ of mandamus.²
