The defendant has moved for an order vacating the judgment imposed by the trial Court following a jury verdict finding the defendant guilty of Murder in the Second Degree , as well as robbery and weapon charges. The defendant received a sentence of 25 years to life on the murder conviction as well as concurrent sentences on the other charges.

The defendant filed a direct appeal of the conviction. The Appellate Division affirmed the conviction. People v. Latouche, 61 A.D.3d 702 (2nd Dep't 2009). Two previous motions pursuant C.P.L §440 were denied. Additionally, the defendant's federal *habeas corpus* petition was denied in 2013.


The defendant now moves to vacate the judgment of the trial court claiming that his trial counsel was ineffective in failing to submit certain documents during the suppression hearing, to wit, documents allegedly demonstrating a finding of borderline mental retardation.

C.P.L. §440.10(3)(c) provides that "the court may deny a motion to vacate a judgment when: [u]pon a previous motion made pursuant to this section, the defendant was in a position adequately to raise the ground or issue underlying the present motion but did not do so." In this case, the defendant has made two prior 440 motions, but has inexplicably failed to raise this issue. Therefore, the Court denies the motion without reaching the merits of the defendant's contention.

This Decision shall constitute the Order of the Court.




