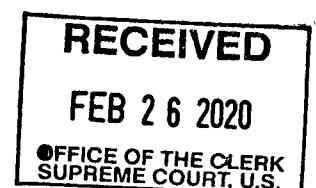
The judgment of the United States Court of Appeals for the District of Columbia Circuit was entered on December 10, 2019. A copy of that opinion and order is attached to this application.

## WHY AN EXTENSION OF TIME IS JUSTIFIED

Hello and Good Day Chief Justice - Mr. Roberts,

My name is Juan Petis McLendon and on December 10, 2019, the Court of Appeals for the District of Columbia Circuit affirmed my conviction based on a violation of the Federal Speedy Trial Act.

On May 25, 2017, Mr. McLendon was found guilty in the Circuit Court for Prince George's County Maryland under case no. #CT151183X.

Then on December 27, 2019, my conviction under Maryland case no. #CT151183X in the Circuit Court for Prince George's County Maryland was overturned on appeal in the Court of Special Appeals of Maryland. The unreported opinion of the Court of Special Appeals of Maryland is attached.

As of the date of submitting this application I am awaiting to be removed from State custody and returned to the local Maryland County Detention Facility located in Prince George's County Maryland. I am indigent and I am not represented by counsel in neither my Federal or State case. I have limited movement at my current housing facility located in Hagerstown Maryland. I am entitled to go to the Law Library twice a week for one hour per visit. The Law Library at this facility has two typewriters. This facility has a L.A.S.I. (Library Assistance to State Institutions) system that allows inmates to order five cases off of the E-Library system. I ordered the Rules of the Supreme Court and am awaiting the copies of the Supreme Court Rules so that I may know how to correctly proceed. Also, I am under duress because I can be released at any time and will have to get myself situated in society once again. Either way I need an extension

of time to file my petition for a writ of certiorari. I am Pro Se. I know that an application to extend the time to file a petition for a writ of certiorari is not favored, but the timing of everything has put me at a disadvantage at the moment. Chief Justice Roberts, I humbly request an additional 60 days to file my petition for a writ of certiorari based on my current and immediate circumstances. Chief Justice feel free to call my lawyer for my State of Maryland case. His information is attached.
