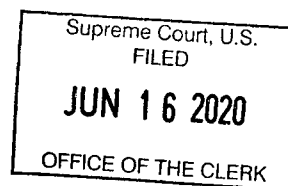

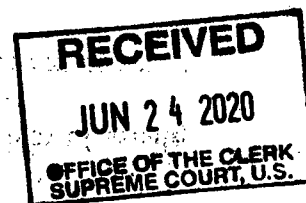
Dear Clerk Harris:
