Re: Winnie Diggs v Neil Gallucci, Chief of Police, City of Carlsbad, California case No. 19-8498

The discrimination and racism that began this awakening: I was on the phone with Fed Biz Access, a government contracting consulting firm in Washing DC. While I was discussing my contractor's capabilities statement" the librarian shouted into the phone "you are not allowed on the phone in the library" she walked away, minutes later two armed police officers were standing over me demanding that I leave the library. I had files open in my lap, my five minute telephone conversation was terminated. As I looked around I counted five others on the phone; one white guy was walking from one end of the library to the other, talking about his new job with the school system. I was the only African American in the library. I sent email communications to California Governor Browns' office, Ethetic and Compliance San Diego, and Mayor Faulconers office, about discrimination and racism in Encinitas California at the Encinitas library. Carlsbad police started following me, in police cars in police uniforms. At 65 years of age I had no record. In May of 2015, Carlsbad police gave me the first of about three tickets leading to the night I was given a DUI charge when sleeping in my car.

There are no longer help organizations providing avenues of grievances; Who are willing to support, change in today's profoundly immoral and wickedly inspired societies. It's about coming up with something different from where we are. Opening up to "different perspectives"to make good changes.

My attempts to open communications with the Carlsbad Police Department were met with silence. The fallacious DUI has caused devastating losses; three automobiles the

last was dented, scared and scratched, windshield wiper blades were removed, driver side rear view mirror was broken. The Volvo was disabled and the Hyundai was towed. Six computers were made inoperative and/or stolen. Money owed me by my employers was ignored. Intellectual properties, i.e, government credentials, medical certification, tax information,...was lost. An incorporation of current personal and business investments; SAVE's business plan and NIH grant application was removed from my computers; a program worth billions in franchising capabilities stolen. I did not even know I had been targeted. During the Christmas holiday 2017, attacks were escalated to physical. I took pictures of laser imprints on my window, lasers that cause extreme anxiety attacks; Once I found out I was targeted I went to the FBI. I was told "it will be defused".

I am turned away by hospitals, I am accosted by police. Courts clerks sabotage my attempts to get a fair trial, in every court so far except the Supreme court. After expunging my record, I opened a case with the District Court San Diego California. District Court clerks destroyed and censored significant documents, and pictures delivered by me to the court and tampered with US mail deliveries to the District Court, I was forced to file charges for mail tampering with the postmaster general and District Court Supervisors. District court did not post documents on pacer.gov. I was able to retrieve stolen documents by buying another Apple computer. The District Court clerks claimed they were incomplete and forced me to redo the complaints on both parties even though there was no response required by the defendants. I discovered later it was a set up. I was severely attacked by agents of the defendants, i.e. tased twice while at the Encinitas Library and again at the Taco Bell in oceanside.

Mechanics in Carlsbad purposely disabled my Volvo; the siege was initiated by Firestone in 2016, when I took the Volvo to get prepared for smog check. The Volvo was disabled to the point I had to tow in from Firestone to another Mechanic shop in Carlsbad. A copy of the towing records are available. The siege continued to the first part of 2019 when I left San Diego. Not able to drive the Volvo I replaced it with a 2005 Hyundai, to take a job with the census, copies of the equip generated agreement is available. The Hyundai was towed June of 2017; documented proof is available. DMV

purposely did not remove the suspension, after I went through the Superior Court San Diego to have the DUI expunged from my record. I was forced to sleep in my disable Volvo, agents of Carlsbad police cut the gas pedal cable, and hood cables were cut. Door locks were compromised, pills were put in my drinking water, siding was removed; I was told by Leal International, the car repair shop I was sent to by Firestone. "we are friends of the police". I slept in the Volvo in the Denny's parking lot on display for over three years while I worked on cases to gain the justice I deserve, and completed my NIH application and SBA loan Application.

The terrorist attacks followed me to Pueblo Colorado. In Pueblo Colorado I was accosted by police when I called for help. while I was under severe attacks by terrorists in the parking lot of the apartment complex and living in the apartment under me. The police and paramedics forced me to go to the hospital, saying my blood pressure was at stroke levels. The Police failed to investigate my reason for the call. At Parkview I was locked away in a cell in the basement of the hospital with blood pressure of 240/114, to induce a stroke or even my death. My shoes, purse and phone were taken. I reported this incident to the FBI after I was refused a meeting with Parkview executive staff. (see attachment Parkview hospital)

I have gone to the police station to file complaints of the terrorist attacks here in Pueblo, so far five times. I was refused report numbers. I recently wrote a letter to the Pueblo Police Chief, August 23, 2020, see attachment(Police Chief Davenport)

The attackers, terrorist, stalker, assailants, extremist, use pain generating mechanisms, i.e. trajectory mechanisms are used to plant probes under my skin, some cause cuts and bleeding especially on my back. While setting or sleeping, mechanisms are used to penetrate my body, leaving ulcers on my privates, causing pain in my chest, spleen, appendix, and naval. I can't stand or sit for any length of time because shock waves pain generated mechanisms on the left breast. Some feel like needles and painful blows to my head, knees, back, are accompanied with blurring impacts to my eyes. My left breast is constantly attacked with pressure that has caused a sis to

develop. My feet have burn imprints from what feel like dull laser burns, and pressure causing tenderness at the arch of my feet.

There are over 2,000,000 American who are wrongly prosecuted in America still today; prosecuted for doing what good American do, fight back.

Federal courts have the sole power to interpret the law. This case is a matter of suffering at the hands of dangerous, extremely wicked, and shockingly evil barbarity men women and young adults; mostly white some mexicans. This case is considered extremely important in helping myself and others. The content though extreme is true; and is sufficiently important. This requires the court to have these wrongs remedied; through an order to cease and desist from acts of terrorism in America. To alter terrorism; taking away funding for programs of this nature, and award monetary damages for loss, pain and suffering past present and future.

I believe I have a right to be treated fairly, in this country, and I am fighting for that right. Hopefully others will not need to suffer as much nor as long. I am begging the court for current and future relief: (Please see Actual Loss)

Actual loss

I want to be compensated for multiple accounts of assaults. Thousands of attacks by rooms of people, while in the libraries, sitting by the ocean in my automobile in San Diego, in restaurants, people walk pass and attacking me with phone apps, Hacking into and destroying my electronics. \$1,100,000.00

LOSS OF INTELLECTUAL PROPERTIES

Dististruction and thief of my intellectual properties, documents and computers.

SAVE (Student and Social Advocates Voices for Education)

In September 2017, SAVE completed and submitted to the National Institution of Health (NIH), a social and economic grant application to research and develop historically underutilized business zones.

SAVE (Social Advocate Voices for Education) program is to recover Historically Underutilized Business (HUB) zones; creating an economic base in underserved communities, that shifts the burden of abuse and losses to affirmative actions. The organization was able to upload the business plan, the grant application, the required attachments and government credentials thru era, a government portal for submissions to the (NIH), before the thief of the completed Program. A billion dollar + loss. Copies of the Business Plan and the entire Grant submission, approved by SBA (HUBZone Program) is available upon request.

myself-tax, resumes, medical credentials, government credentials, pictures of family and friends; information; grant writing proposal and business description.....\$1,132,000.00 for lost time and research.

SERVICES REPAIRS and REPLACEMENTS

- Apple Macbook Pro 2008-stolen, Grants.gov application for grant with the National Institute of health(NIH), grant writing business description...keyboard stopped working
- Apple Macbook Pro 2012-3 repairs, stolen Grants.gov application for grant with the National Institute of Health (NIH).
- Dell Computer= 8 Repairs, replacement of documents, technology and miscellaneous equipment and labor \$12,000.00

Loss of viable employment; I was contracted with the Department of Commerce 2016 to date at a pay rate of \$17,00 per hour, 595.00 per week, Contracted to work in California City, CA, Kern Co, for six months= \$14,280, contract documents are available.

- Department of Labor and Standards in Employment (DLSE), "friends of the police" allowed and assisted in extorting money from me. I with Alta Golden \$3000.00,
- Right At Home the assignment was 287,00 per day, 1400 per week, for the duration of the contract with the client, estimated 12 months (12 months) @ 1400 per week, = 72,800;
- Life Line \$187 per day, 4 days per week, x52 week = \$38,896.00
- Deliberately disabling my Volvo. The Cost of purchasing a 1982 limited edition, classic, in mint condition \$3,179 + added up grades; volvo custom rims was broken and or removed
- Thousands of dollars lost in picture, copied documents, and certified postage used to send off packages to government offices and others;
- Forced to use public transportation; increased cost of insurance,

MEDICAL

- I want to get compensated for past attacks on my body cost of medical and pain and suffering
- current cost of treatment cost of medical and pain and suffering
- and future cost if I survive the attacks medical and pain and suffering

NEGLIGENCE EMOTIONAL AND FINANCIAL DAMAGES

- Victimized and Forced to pay court, DMV, and others
- Forced to sleep in my broken down Volvo, 2016-2019

- Neglect-The car I purchased to replace the Volvo, so that I could take a job in California City was towed, DMV neglected removing the suspension in their computer system
- I took pictures of laser imprints on my window, lasers that cause extreme anxiety attacks
- Pictures were sent to government officials regarding the attacks with electrical microwave technology, information not delivered to the addressee.
- I was forced to open a case with the Postmaster General.
- If I report injuries to police I am threatened with criminal and mental institutions, incarceration for the mentally insane "delusional"
- Being made a target, and still have to protect myself from this type of injustice \$1,000,000,000.00

I am a African American woman, a grandmother, a government contractor, a retired school teacher, with compassion, love and concern for the future of our children and the future of America. I am attempting to do business in the United States; business that will allow communities to grow positive. I want to help by investing in programs that will do just that. Does the rich in America suffer when there's no poverty, poor environment or social inequality? No, we grow rich with spirit, and share our prosperity. My intentions now and always have been for the sake of good. I am no fool, I know it takes money; this is why my Government Program is called SAVE's Mentor/Trainee OJT program. I our chance to invest in our future.

When my Hp computer was stolen - Book transcript, and published copies of the "Prerequisite for Control (BI-Laws)By Laws; Written and researched by WinnieOdette Diggs. Was stolen along with everything I've created;

Jim Crow Laws still apply to African Americans.

The following is happening to me because I am an amazing person, being targeted by evil comes with my passion to help good things happen...

I moved to Woodhaven Apartments, apartment 326, my rent went up the same day I moved in; I had to clean the apartment myself, no pay. I had to jump in and out of the shower to keep from getting too hot water on my body. The problem was not fixed. I had no control over the temperature of the water. A serious injury caused me to need knee replacement on my left leg; this was taken to local court. I was forced out of my lease, because of this. (See attachments Woodhaven Apt)
