Aliza Hochman Bloom, an Assistant Federal Defender and appointed counsel for David Bruce Hardman in this direct criminal appeal, has moved to withdraw from further representation of the appellant and filed a brief pursuant to *Anders v. California*, 386 U.S. 738 (1967). In response, Hardman moved for leave to dismiss his counsel and proceed pro se on appeal.
