Pursuant to Supreme Court Rule 39.1, Petitioner Lary James Plumlee requests leave to file the attached Petition for Writ of Certiorari without prepayment of costs and to proceed *in forma pauperis*. Plumlee has been granted leave to do so in state and federal court. In state court, counsel was appointed to represent Plumlee at trial, on direct appeal, and in state post-conviction proceedings. In his federal habeas corpus proceedings, the United States District Court granted Plumlee's motion for appointment of counsel under the Criminal Justice Act and appointed the Federal Public Defender to represent him. *See Plumlee v. Ignacio, Warden, et. al.* No. 3:00-cv-00244-DWH-ECR, ECF No. 3, 23.

Plumlee was unable attached a signed financial declaration. As explained in the accompanying declaration from Jonathan M. Kirshbaum, counsel for Plumlee attempted to obtain a signed financial declaration from Plumlee. Plumlee sent two signed, completed declarations to counsel over the past month, as far back as April 25. However, due to the pandemic, there has been a significant delay in counsel's incoming mail. As a result, counsel has yet to receive either of the signed declarations. Currently, the Nevada Department of Corrections is not allowing in-person visits at the prison. As a substitute, counsel filled out the financial declaration using information he obtained from Plumlee over the phone on May 14, 2020. Plumlee declared to counsel under penalty of perjury that the information he was giving counsel over the phone was true and accurate. Counsel has attached to this motion the unsigned declaration with the information counsel obtained from Plumlee.


