FURTHERMORE,

- 1) No State shall enter into any Treaty, Alliance, or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; **make any Thing but gold and silver Coin a Tender in Payment of Debts**; pass any Bill of Attainder, ex post facto Law, or Law impairing the Obligation of Contracts, or grant any Title of Nobility,
- 2) There has not been any lawful money in circulation whereby debts can be satisfied since 1933 as President Franklyn D Roosevelt suspended the gold standard per House Joint Resolution 192.

I Affirm, for the Record, that I do not have, or possess, any gold or silver coin, as prescribed by United States Constitutional Law, which is the lawful money to pay the restricting demands, conditionally commanded by Employees and Contractors of the Court.
