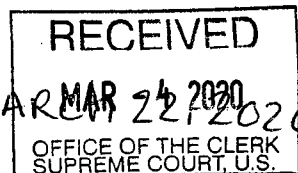
MOTION FOR EXTENSION

18 Petitioner MOVES FOR AN EXTENSION OF TIME TO FILE  
19 Petition FOR Writ OF CERTIORARI.

20 THE United States COURT OF APPEALS FOR the 9th Circuit  
21 entered their final judgment on MY CRIMINAL APPEAL  
22 CASE # 19-55921 in case name CHARLES T. KIRVIN  
23 vs. THE PEOPLE OF THE STATE OF CALIFORNIA, et al.,  
24 on December 23, 2019. Petitioner have 90 days from  
25 THAT DATE TO file Petition FOR Writ OF CERTIORARI  
26 in the United States SUPREME COURT.

28 1) Petition For Writ OF CERTIORARI is due MARCH 24, 2020.



1 2) Petitioner is REQUESTING A 30 days extension to file

4 for extension OF Time:

5 Petitioner declares that I Am A LAYMAN at Law  
6 and incarcerated and have an Mental Disability that  
7 makes it hard for me to read and understand material  
8 REGARDING MY case and due to circumstances sur-  
9 rounding my conditions of confinement, i.e., the noisy  
10 distractions of the Law Libraries and buildings, lack  
11 of LEGAL Assistance, Limited Access to Law Library, and  
12 MULTIPLE LEGAL ISSUES from being subjected to a lot of  
13 unjust treatment which I'm having difficulty under-  
14 standing. I need additional time to prepare my  
15 Petition for Writ of CERTIORARI being I AM HOUSED  
16 AT THE PRISON which I filed the civil Action AGAINST  
17 IN THIS COURT on Jan. 23, 2020 which took up 30  
18 days of Preparation time I had to prepare for  
19 this case and Prison officials are intentionally  
20 ENGAGING IN TACTICS THAT MAKES IT HARD  
21 for me to do LEGAL RESEARCH AND PROCESS MY CASE.

22 I ALSO GOT AN Inmate REQUEST FOR Assistance  
23 FROM THE COURT FORM THAT THE PRISON OFFICIALS  
24 signed which REFLECTS I CLAIM TO HAVE A MENTAL  
25 Disability covered under the American With  
26 Disability ACT (ADA), and MY MENTAL Disability  
27 MAKES it hard FOR ME TO READ AND understand  
28 material REGARDING MY CASE. In order To Proceed

1 With MY CASE I will be REQUESTING Accommodation  
2 of assignment of counsel once I'm GRANTED  
3 Certiorari. (EXHIBIT A) is a COPY OF THAT FORM.

4 I REQUESTING THAT THE COURT TO CONSIDER  
5 THAT LAWYER'S HAVE THE BENEFIT OF Paid  
6 Paralegals TO HELP THEM AND allowed 90 days  
7 TO FILE THE Petition For Writ OF Certiorari. I  
8 Was Sent entry OF Judgement From the U.S. COURT  
9 OF APPEALS For the 9th Circuit ON DECEMBER 23, 2020  
10 Which I was currently working on Application NO.  
11 19A810 in CHARLES T. Kirvin Vs. L. GRANT, et, al.  
12 Took up 30 days OF THE Preparation Time  
13 I needed to FILE THE Petition For Writ OF  
14 CERTIORARI SO I'm REQUESTING an additional  
15 30 days until April 21, 2020 For the Fore-said
