


# Certificate of the Service

Re: Motion to rehear my petition

Helpless unprotected defenseless powerless indigent victims expect ultimate responsibility of the Supreme Court as guardian of the Constitution, and the highest tribunal in the Nation for all cases to ensure equal justice for everybody as expressed above the main entrance, "**EQUAL JUSTICE UNDER LAW**". It's guaranteed by US Constitutional and Civil Rights. Providing justice should be considered far more crucial and significant when preserving and protecting helpless citizens whose lives destroyed by nonstop conspiracies made by uncivilized human-like creatures infiltrated everywhere and care just for their personal and political gains.

The US Supreme Court is the last hope of weak, defenseless unprotected people whose Constitutional and Civil Rights destroyed by powerful politically-religiously protected persons. These poor victims cannot hire personal attorney due to intentional indigence imposed by powerful government-based persons.

This is my motion to request rehearing of my petition. It's not just a simple conspiracy case, but it will affect the entire country, and protect many other similar victims of corrupt system who fearfully have to shut their mouth. It will definitely prevent the same inhumanity, cruelty and injustice in the future. The legal issues that mentioned in the petition have a large constitutional impact, and are crucial to people, so the answers to these important legal questions affect the whole nation. Definitely, public reaction would be significantly against corruption and injustice, since these are priority in every state.

My appeal involves the U.S. Constitution, proves that my rights, under the Bill of Rights, were intentionally ignored, denied and violated by the state, and errors made on purpose in the courts that destroyed my due process rights. The state court's political and unfair ruling ruined my Constitutional Rights and consequently my entire life. This is landmark case because of its legal significance and has lasting effect on the application of US Constitutional Rights concerning Rights, Liberties and Life, so it would be a historical message for future reference.

The American legal system is a Common Law system, and also, courts will try to stay consistent in stare decisis, but unfortunately, VA court of appeal not only intentionally violated my Constitutional Rights but ignored the decisions on previous court rulings in similar cases. No law or action can contradict the U.S. Constitution, which is the supreme law of the land.

The nonstop conspiracies increased in late 2016 to force me to shut my mouth and stop writing against corruption, injustice and cruelty in Iran Islamic regime, and the secret cooperation of West politicians and agents with the regime and other terrorist islamists. It's the violation of my five freedoms esp. speech & religion, guaranteed by the 1<sup>st</sup> Amendment. In other word, federal agents tried to suppress me by violation of my freedom of expression. The purpose of free speech is to protect the unpopular minority viewpoint from being overpowered by the government or by the majority whose provocative and offensive political opinions are **protected speech**, and fearlessly suppress the minority viewpoint by any means.

MY 1<sup>st</sup>, 4<sup>th</sup> 5<sup>th</sup> 6<sup>th</sup> 9<sup>th</sup> 14<sup>th</sup> Amendment Constitutional Rights and Civil Rights Act, Equal Protection and Due process have been totally destroyed, so what is more crucial than a conspiracy case that has fully destroyed an innocent's whole life? Hearing for my case will revive my destroyed life and put an end to the same cases in the future. It will protect people from being abused by a powerful government-based forces, consequently, protect public safety and national security.

I have been suffering from real financial damages, physical harms and utmost psychological stresses, my valuables robbed, nonstop damages to my car, my laptops destroyed (5 in 4 years), my jobs ruined ...

Lack of political and religious support to my case made injustice and unfair orders. I would appreciate you to revive my life by hearing the case and issuing a fair order, otherwise I have to go back Iran & executed, or die in poverty in democratic USA!
