On March 30, 2018, Mr. Michael Garry, pro se, filed a petition for review of a May 20, 2002 court of appeals decision denying his motion for reconsideration. This court dismissed the petition for review by order dated April 5, 2018, on the ground that the petition for review was a request for the court to reconsider its May 28, 2002 order that dismissed a request for the extension of time to file a petition for review, and that there was no statutory authority permitting a motion for reconsideration of an order denying a petition for review, Archdiocese of Milwaukee v. City of Milwaukee, 91 Wis. 2d 625, 284 N.W.2d 29 (1979), and that the request was untimely. See Wis. Stat. §§ 808.10 and 809.62(1m), and First Wisconsin National Bank of Madison v. Nicholaou, 87 Wis. 2d 360, 274 N.W.2d 704 (1979); see also Gunderson v. State, 106 Wis. 2d 611, 318 N.W.2d 779 (1982). In addition, the equitable doctrine of laches precluded this very belated request. Sawyer v. Midelfort, 227 Wis. 2d 124, 159, 595 N.W.2d 423 (1999) (laches is an

equitable doctrine whereby a party that delays making a claim may lose its right to assert that claim).

On March 30, 2018, Mr. Michael Garry, pro se, filed a petition for review of a May 20, 2002, court of appeals decision denying his motion for reconsideration.

The court has reviewed the documents Mr. Garry has submitted. In 1991, Mr. Garry was injured working as a service engineer in Muscat, Oman, while employed by the Trane Company. He sought Worker's Compensation benefits from the Wisconsin Department of Industry, Labor and Human Relations (LIRC). Administrative Law Judge William Phillips, Jr. conducted hearings in February 1994 and March 1995, and recommended dismissal of Mr. Garry's application for lack of jurisdiction, by order dated March 29, 1996. On August 21, 1996, LIRC dismissed his petition for review of that order as untimely. Mr. Garry then waited over four years before attempting to seek review of this administrative determination from the Dane County Circuit Court. The Dane County Circuit Court dismissed his petition, with prejudice, by order dated September 19, 2001. His ensuing appeal to the court of appeals was also untimely.

and this court dismissed his motion seeking to extend the time to petition for review by order dated May 28, 2002.

Mr. Garry now, 16 years later, again asks this court for review. He raises certain substantive arguments relating to the underlying decision.

However, this petition is, although belated, a request that this court reconsider its order denying the petition for review filed in this court. There is no statutory authority permitting a motion for reconsideration of an order denying a petition for review. Archdiocese of Milwaukee v. City of Milwaukee, 91 Wis. 2d 625, 284 N.W.2d 29 (1979). Moreover, this request is untimely. See Wis. Stat. §§ 808.10 and 809.62(1m), and First Wisconsin National Bank of Madison v. Nicholaou, 87 Wis. 2d 360, 274 N.W.2d 704 (1979); see also Gunderson v. State, 106 Wis. 2d 611, 318 N.W.2d 779 (1982). In addition, the equitable doctrine of laches would independently preclude this very belated request. Sawyer v. Midelfort, 227 Wis. 2d 124, 159, 595 N.W.2d 423 (1999) (laches is an equitable doctrine whereby a party that delays making a claim may lose its right to assert that claim). Therefore,

Before Vergeront, P.J., Roggensack and Lundsten, JJ. .

The appellant takes this appeal from an order denying reconsideration of a dismissal order. An appeal cannot be taken from an order denying a motion for reconsideration if the motion presents the same issues as those determined in the original order. *Silverton Enterprises v. General Casualty Co.*, 143 Wis. 2d 661, 665, 422 N.W.2d 154 (Ct. App. 1988). Upon review of the record and the party's jurisdiction briefs, we conclude that the appellant's reconsideration motion presented no issues beyond those he presented to the court in his original petition. Therefore,

IT IS ORDERED that the appeal is dismissed. *See id.*
