There needs to be a ruling, a law that ALL cases in courts be reviewed for corruption by court officials.

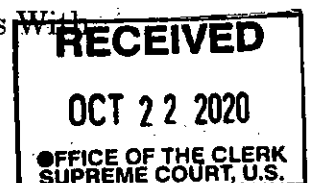
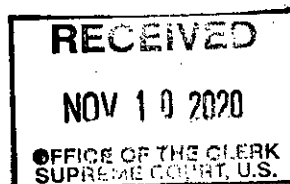

My LAST HOPE, you WERE my LAST HOPE. I will continue to fight for my mom.






