Dear Mr. Harris:

This Court has requested a response from the Respondents, Jill Sessions, et al, in this matter. The brief in opposition is currently due on April 20, 2020. Due to the large amount of COVID-19 related litigation our office is handling, the State requests a second extension of thirty days in which to file its brief in opposition. The new due date would be May 20, 2020.

Respondents have communicated with counsel for the Petitioner, William Pesnell, who said he opposes the State's request because the COVID-19 "issue will likely be recurring in nature given the extended shutdown." See Pesnell Correspondence (attached).

Under this Court's Order of March 19, 2020, "motions for extensions of time pursuant to Rule 30.4 will ordinarily be granted by the Clerk as a matter of course if the grounds for the application are difficulties relating to COVID-19 and if the length of the extension requested is reasonable under the circumstances." Supreme Court Order, March, 19, 2020,

The State's request for an additional 30 days is reasonable under the circumstances. The Louisiana Attorney General's office has been inundated with a flood of COVID-19 related litigation over the past several weeks as the State seeks to enforce measures to contain the spread of the disease. This litigation presents complex questions of constitutional law, but none of the issues is time sensitive or urgent.
