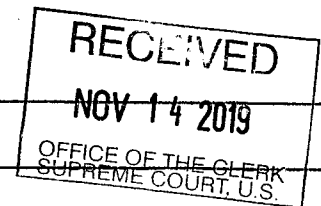

4. On September 20, 2019 petitioner had left hand surgery for which his hand is in a cast. Anticipated removal November 8, 2019.

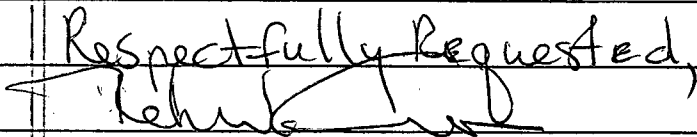
