MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

Now comes, Yara Chum, the petitioner and pursuant to Supreme Court Rule 39, moves for leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.

In support of this motion, Mr. Chum asserts the following:

1. Mr. Chum has been incarcerated at the Adult Correctional Institutions in Cranston, Rhode Island since 2010, and is currently not scheduled to be released until 2028.
2. Mr. Chum has previously been granted leave to proceed *in forma pauperis* in proceedings related to this case in the Rhode Island Superior Court and the Federal District Court of Rhode Island. *See attached Orders*.
3. Mr. Chum was represented by court-appointed counsel during the state court litigation of the criminal charges forming the basis for this petition and by court-appointed counsel and the Rhode Island Public Defender's Office during state court post-conviction proceedings. The Rhode Island Public Defender's Office also

represented Mr. Chum in the federal habeas proceedings in the Federal District Court and the Court of Appeals for the First Circuit.

4. Mr. Chum owes \$3,125 in court costs to the Rhode Island Superior Court. *See attached* Docket Sheets.
5. Mr. Chum earns approximately \$3 per day at his prison job. He has \$1,000 in his prison encumbered account, which he cannot access until he is released. As of May 31, 2020, he had \$97.57 available to use from his spending account. He has no other assets. *See attached* Affidavit; Inmate Consolidated Statement (May 1, 2019-May 20, 2020)

WHEREFORE, Mr. Chum requests that this Court issue an Order granting him permission to proceed without payments of costs and to proceed *in forma pauperis*.


This matter came before the Court on Dec. 19, 2014. After due consideration it is hereby


ORDER

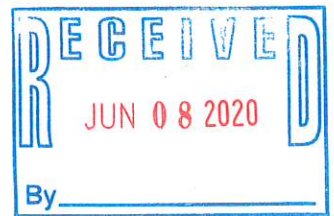
