

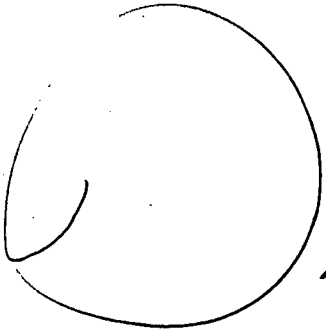



On the violation of the (V111-amendment) there is more than reasonable proof, that the federal judges in the state of Texas, and fifth circuit, are incorrupt spiritual players to many violations.
