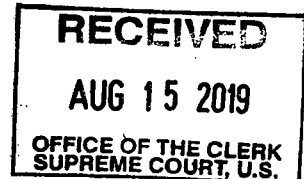

FIRST EXTENSION OF TIME



Dear OFFICE OF THE CLERK, Petitioner moves this Honorable court for an extension of 90 days in which to file. Petitioner filed a Motion for Reconsideration to the 11th Cir. R.22-1(c) and 27,-2, District Court dismissal of his 28 U.S.C. § 2254 Petition for Writ of Habeas Corpus as time-barred.


Upon review, Petitioner's Motion in the SUPREME COURT OF THE UNITED STATES, Petition for Writ of Certiorari is due to be served on or before 08/29/2019. Response in the above-styled cause.

1. The Petitioner has not previously sought any extension in the instant case.
2. Petitioner has timely filed a 2254 in Middle District Court on 08/02/2018, Case 3:17CV-00205-HES-JBT Respondents ORDER decision by court that pursuant to the court's order entered August 2nd, 2018, the petition for Writ of Habeas Corpus is dismissed with prejudice.
3. The Petitioner's Response is due to be served on or before August 29, 2019.
4. The Petitioner was on track to have his writ of certiorari timely filed however the Petitioner has rearrested and booked in the Jacksonville Detention Center (jail) by the Jacksonville Sheriff's office.
5. On June 27, 2019 the Petitioner was transported to the Jacksonville Jail from the Union Correctional Institution Raiford, Florida Petitioner has been in the custody of the Florida Department of Corrections since 02/02/2012.
6. The Petitioner is in the Jacksonville Jail for a surprise potential victim a sexual battery cold case on May 19, 2019 two JSO Detectives came to the Union Institution and interviewed the petitioner and advised him of his rights and showed him a picture of a girl and asked him if he knew her and the Petitioner said no. ON 03/13/2010 this incident took place.

7. The Petitioner is relying upon the help of an institutional certified law clerk(inmate) to fully articulate his position or comply with the correct procedures.
8. This request is not made for the purpose of unnecessary delay, is made in good faith, and will not unduly prejudice.
9. Due to the unforeseen circumstance, in an abundance of caution Petitioner request an additional (90) days extension of time.
10. The Petitioner has filed pro se, #102281 in this case untrained.

THEREFORE, the Petitioner respectfully request this Honorable Court of the SUPREME COURT OF THE UNITED STATES, to grant an extension of 90 days
