**APPLICATION FOR A 60-DAY EXTENSION OF TIME TO FILE A PETITION
FOR A WRIT OF CERTIORARI FROM THE JUDGMENT OF THE
UNITED STATES COURT OF APPEALS FOR THE ELEVENTH CIRCUIT**

**TO THE HONORABLE CLARENCE THOMAS, ASSOCIATE JUSTICE OF
THE SUPREME COURT OF THE UNITED STATES AND CIRCUIT
JUSTICE FOR THE ELEVENTH CIRCUIT**

Petitioner, Patrick Killen, Jr., respectfully requests a 60-day extension of time, to and including November 8, 2019, within which to file a petition for a writ of certiorari from the judgment of the United States Court of Appeals for the Eleventh Circuit. Mr. Killen has not previously sought an extension of time from this Court.

Petitioner is filing this Application at least ten days before the filing date, which is September 9, 2019. *See* S.Ct. R. 13.5. The jurisdiction of this Court will be invoked under 28 U.S.C. § 1254(1).

Mr. Killen appealed the district court's imposition of a 50-year sentence to the

United States Court of Appeals for the Eleventh Circuit. The Eleventh Circuit affirmed the district court's sentence in an unpublished opinion on June 10, 2019.

United States v. Killen, Appeal No. 18-13761 (11th Cir. June 10, 2019) (Attached).

Mr. Killen has been involved in his representation. However, Mr. Killen is housed at the Federal Penitentiary in Coleman, Florida, approximately a five hour drive from undersigned counsel and communication on the issue(s) to be raised has been difficult. Undersigned counsel believes that additional time will be important for the effective representation of Mr. Killen. No party will be prejudiced by the granting of a 60-day extension.

Accordingly, Petitioner respectfully requests that an order be entered extending the time to file a petition for writ of certiorari by sixty days, to and including November 8, 2019.
