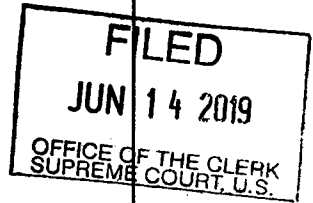

Plaintiff, Arthur Lopez's First Request
for a 90 Day Extension To File a Petition
for Writ of Certiorari, extending the Current
August 19th or August 28th Deadline, depending on whether the
90 Day clock starts running on the Submitted Date
of May 21st, 2019 or Filed Date of May 30th, 2019 (see
United States Court of Appeals Affirming Lower Courts Dismissal
Order attached [reflecting May 21st, 2019 - Submitted in the Center and
May 30th, 2019 Filed on the upper right hand corner], to November
18th, 2019 (Monday) or November 26th, 2019 (Tuesday).

1 This First Extension Request is for Good Cause
2 since the lead counsel for this case, Richard
3 Sontag, who derailed the initial State
4 Court action, resorted to Fraud and Misrepresentation and
5 to have the Superior Court of California, County of
6 Orange Judge Francisco Jimeno grant Dismissal
7 without Litigation much less a Jury Trial as
8 had been sought. Moreover, this lead counsel is
9 also an employee of the same Superior Court of
10 California, County of Orange as a Volunteer
11 Judge without pay. Moreover even, he is
12 also lead counsel for a second Civil Case
13 currently on this Court's Docket under
14 No. M-5238 - "Arthur Lopez v. The Irvine
15 Company Apartment Communities, Inc. et al."
16 True to Form, he attempted to Derail a State
17 Action against this defendant, Irvine Company, by
18 resorting to Trickery and Deceit seeking to
19 Deprive Plaintiff of his U.S. Constitutional Civil
20 Rights under the 14th Amendment by Attempting
21 To Bar Plaintiff from proceeding on the Civil Action
22 without depositing \$100,000.⁰² despite Plaintiff having
23 no income from employment for several years and
24 having several permanent injuries/disabilities doctor

12 For all these reasons and many more Plaintiff (computer access)
13 Arthur Lopez humbly and respectfully seeks
14 your Honor's granting of this 90 Day Extension
15 to file the Petition for Writ of Certiorari on
16 this matter against MUFJ Union Bank, N.A.,
17 et al (U.S. Court of Appeals Case # 18-55748 -
18 District Court Case # 8:17-cv-01466-JLS-KES).

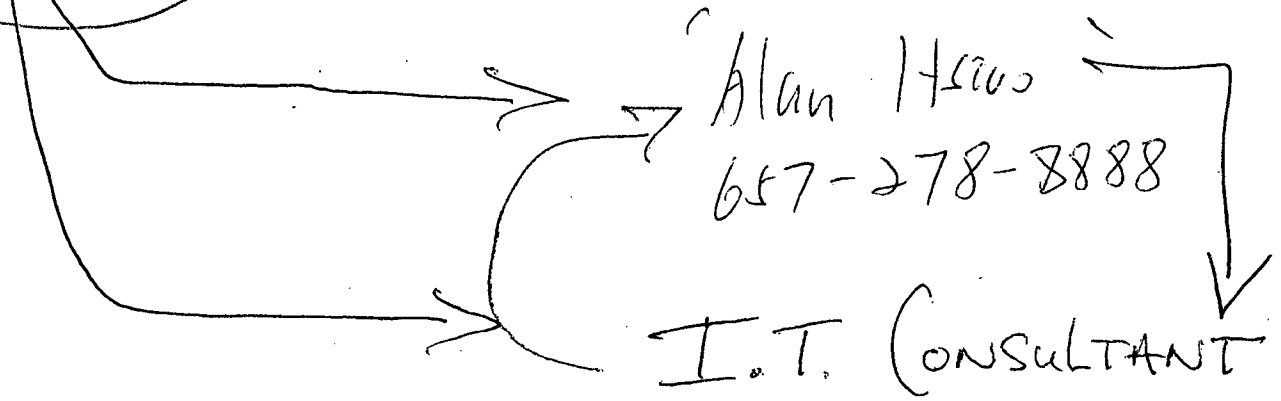
