**DONOVAN DAVIS, JR.'S MOTION REQUESTING ADDITIONAL  
60 DAYS TO PETITION FOR A WRIT OF CERTIORARI**

On July 17, 2019, the Eleventh Circuit denied Donovan Davis Jr.'s petition for rehearing in consolidated appeals 15-13997, 16-17781, 17-12057. (See Attached). As such, Mr. Davis has 90 days to petition for a writ of certiorari. Because Mr. Davis is an incarcerated individual proceeding pro se, there are many obstacles to overcome when preparing the petition, or any legal filing.


Out of the abundance of caution, Mr. Davis requests an additional 60 days to correctly prepare his filing.

Mr. Davis is incarcerated at FCI Coleman Low in Coleman, Florida. FCI Coleman is subject to numerous daily recalls and lock-down situations for reasons ranging from: staff shortages and training; bad weather conditions; census counts; institutional counts; shakedowns; cutting grass; fights; inspections; security breaches; and many other reasons that inmates are not informed of.

In addition, there are limited availability of resources in the law library: 1 copy machine (currently out-of-service and waiting for parts) available 3 times a day in 30 minutes intervals, 4 days a week; 8 non-memory typewriters (only 5 power cords available); and 12 law library computers for over 2,000 inmates. The limited access to these resources restricts Mr. Davis's ability to properly research and prepare his filing within the current allotted time limit.

Therefore, Mr. Davis respectfully requests an additional 60 days to overcome these upcoming obstacles and properly prepare the petition.
