## MEMORANDUM OF POINTS AND AUTHORITIES

Petitioner's affidavit reveals that Baldwin vs. Denham, Circuit Court No. 18WR-PN00091 (exhibit "1(b)), application for transfer to the Supreme Court of Missouri began after July 9, 2019, to justify the reasons why an extended time is required to file his petition for a writ of certiorari. The mailing of this motion is timely, and is "within the 10 days" before the petition is due as described by Rule 13, 5 and Rule 30, 2.


Thus, under Rule 21, Motions to the Court, in relevant part: "( c) the moving party shall file an original and 10 copies . . . 3. A motion to the Court shall be filed with the Clerk and shall be accompanied by proof of service as required by Rule 29." Id.

In addition, pursuant to Rule 39; a motion for leave to proceed in forma pauperis precede the filing of this motion for the purpose of waiving filing fee cost under Rule 38..
