

Petitioner, Nina Shahin (maiden name, Slavgorodskaya) is of Ukrainian national origin. On December 18 of this year she will be 70 years old. This is not the first time Petitioner is attempting to file Petition for Writ of Certiorari and she has never had problems with getting Rules of this Court before in order to comply with the Court's standards. In her age, with poor eye sight, and limited financial resources (she receives social security on her husband's work history)¹ she needs a hard copy of the Rules in order to carefully read, understand, highlight, and comply with all of them. It is her understanding that the Court adopted new Rules in 2019 and the Petitioner needs a copy in order to file Petition for Writ of Certiorari.

For the first time Petitioner called the Court on October 23, 2019, was directed through automated channels and left her name and address but received nothing. She called again the Court on November 1, 2019, talked to an operator, left her name and telephone number and received nothing again. On November 8, 2019 she wrote a formal request along with complaint of apparent discrimination and corruption in responding to her request and mailed it by priority mail with paying \$7.35. See copy of that document in **Exhibit A** along with the receipt from the post office. It appears that the document was delivered to the US Supreme Court on November 12, 2019 (see copy of the USPS tracking number search in **Exhibit B**) but again Petitioner received no response or Rules of the Court. Instead she

¹ Petitioner's husband, Mazen Shahin, is of Egyptian national origin, and is working as Professor of Mathematics at Delaware State University. It was him who obtained a legal immigrant visa (i.e., green card) arranged by College Misericordia (now University) in Dallas, PA who sought his employment that our family came to the US in 1989 from Kuwait where we lived and worked for ten years.

received unsolicited letter from a law firm in Florida on apparent reference from the US Supreme Court which raises a question of whether the Court operates as a sales medium for those law firms interested in providing services to potential petitioners. Copy of that letter is provided in **Exhibit C.** Communication of the Clerk of the Court with Mr. Rod Curry dated August 1, 2007 provided on the reverse of that letter is questionable especially in view of the wording about "Brief Relief" which has nothing to do with "Petition for Writ of Certiorari."

Today is November 22, 2019 and more than a month has already passed with Petitioner unable to get Rules of Court.

Taking into consideration that Petitioner and her husband are facing discrimination every day of their lives in every aspect of their lives (financial, economical, post office service, employments, civil rights violations, etc.) and in this particular case Petitioner faced with direct verbal insults from the Chief Justice of the Delaware Supreme Court² who colluded with professional attorneys by soliciting

² It was not the first case when Petitioner's constitutional rights for 'due process' and 'equal protection' were violated. Being fed up with those gross violations that happened on a systematic basis he wrote Petition for Impeachment of that judge under provisions of the Delaware Constitution and two other justices of the Delaware courts) and attempted to deliver it to the Senator from their district (Trey Paradee) who refused to accept it because all those against whom Petition was written were, he said, "his childhood 'friends.'" It was that Senator who originated a bill (DE Turf Bill) during last legislative session this summer deeply at night to benefit his brother (John Paradee) and whose sister (Jacqueline Mette) working as a deputy legal counsel for the Delaware governor, apparently, approved that bill for the governor's signature. Senator wrote in the local newspaper *The News Journal* November 4, 2019 issue ('Opinion' section) his claim that "My Family Did Not Plot to Pass DE Turf Bill" which was preceded by the "Editor's note that "*The News Journal* stands by its reporting, but publishing Sen. Paradee's views in the interest of fairness." This is a good example of how Delaware legislature and government operate and where government positions are reserved for the legislators themselves (double dipping), their relatives and family members and why Petitioner with her high qualifications was never able to find a job in Delaware State. Petitioner attempted to deliver the Petition to the Chair of the Senate Judicial Committee and the Governor but to no avail. Chief Justice, Leo Strine, though resigned effective September 2019 although Petitioner is not sure that it was the result of her Petition for his Impeachment.

their request for attorneys fees reimbursement and then approving those requests, when those attorneys submitted to the court perjuries of their "witnesses" which Petitioner was not allowed to prove, disregard and misapplication of the rules of federal anti discrimination laws and rules for judicial transfer for lack of subject matter jurisdiction, filing this Petition is of the most importance in protecting Petitioner's civil rights.

Petitioner, therefore, respectfully requests this Court to extend deadline for filing her Petition for Writ of Certiorari in this case for 90 days from the date Petitioner receives Rules of the United States Supreme Court or at least from the date the Rules are mailed to the Petitioner and the date is recorded by the Clerk of the Court.
