MOTION FOR EXTENSION OF TIME TO FILE
WRIT OF CERTIORARI

TO THE HONORABLE JUSTICE OF SAID COURT:

Comes now, Joseph Wayne Hill, Petitioner. Pro se, in the above styled action and files this, his Motion For Extension Of Time To File Writ Of Certiorari, pursuant to Rule 13.5, Rules of Supreme Court of the United States, and in support would show the following:

1. Movant is currently incarcerated at the Eastham Unit-TDCJ-CID; where he is only allowed (10) hours a week per policy to research caselaw and supportive authority to properly file his petition for writ of certiorari.
2. Movant would show that November 12, 2019; Movant received notice from the Clerk of the Court, United States Court of Appeals for the Fifth Circuit, that his Rule 60(b)(6) "COA" Motion, requesting relief from judgment from his denial of federal habeas corpus, in Civil Action No. 4:15-cv-1744; Case No. 19-20071 had been denied.
3. Movant would show that on December 28, 2018, he filed his Rule 60(b)(6) Motion for Relief from Judgment and/or Order with the United States District Court, Southern District of Texas, Houston Division, alleging 1. the judgment is void as a matter of law; 2. the judgment is based on an

earlier judgment that has been reversed or vacated; and applying it prospectively is no longer equitable; and 3. "extraordinary circumstances" justifies or warrants vacating the judgment.

4. Movant would show, that attached hereto is the Mandate under Case No. 19-20071, signed by United States Circuit Judge, James L. Dennis (Exhibit "A", Fifth Cir. Case No. 19-20071; Hill v. Davis, filed Nov. 1, 2019)
5. Movant would further show, that his motion for extension of time is not made for the purpose of delay, but for good cause in order that justice may be done in this matter.

Wherefore, Premises Considered, Petitioner prays that this Honorable Court would grant his motion for extension of time to file writ of certiorari. Thereby, granting Petitioner (60) extra days to file his Petition for Writ of Certiorari.
