******* AFFIDAVIT OF LANDRY DIXON *******

Before ME, the undersigned authority, LANDRY DIXON, AFFIANT, did appear and make the following declarative statement of facts surrounding his timely submission to the US Supreme Court Clerk's Office of his Movant REQUEST for a 50-day TIME EXTENSION to file his Petition for a WRIT OF CERTIORARI in the captioned Fifth Circuit Civil Appellant case # 19-30123.

Affiant avers that he survived a 20+ foot fall on 10/28/2019 at about 5 pm CST. EMS transported affiant to a local University Trauma Center, several minutes subsequent to his massive fall. Affiant sustained (1) a shattered left hip and femur, (2) a fractured left upper optic area, as well as (3) multiple bruises and contusions about his midsection, (4) his bilateral abdominal flanks, (5) his lower back and (6) his entire chest. Affiant underwent several hours of surgical procedures on 10/29/2019. (See relevant UCMC medical papers)

Affiant avers that on 11/04/2019 he engaged the services of a San Antonio, Texas relative of his to convey his written REQUEST for a TIME EXTENSION to file his Petition for a Writ of Certiorari in the captioned Fifth Circuit Case.


Affiant avers that on 11/05/2019 a UPS Store Rep did at 06:39:13 pm CST forward the Plaintiff-Appellant's REQUEST to the Washington, DC Office of the Honorable Clerk of the US Supreme Court. (See UPS data sheet)

Affiant avers that he began his slow UCMC outpatient rehab activities on 11/11/2019. (See relevant UCMC medical papers)

Affiant avers that it was on 11/20/2019 when he *first* learned that his *UPS sent* Time Extension Request had been USPS postal marked on 11/14/2019. Affiant does not understand how such a tardy date *fiasco* could have eventuated relative to his dire request for a 50-day TIME EXTENSION TO FILE HIS PETITION FOR A WRIT OF CERTIORARI.

Affiant avers and affirms that all statements of fact and supportive UPS Store and UCMC medical documentations are true and accurate representations of the totality of the situation and circumstances surrounding the person of the AFFIANT, LANDRY DIXON, and his timely submission for the prudent consideration of the Honorable Clerk of the United States Supreme Court.
