19||Requests That The JUSTICE ALLOTTED TO THE [CALIFORNIA] NINTH CIRCUIT COURT OF

20||APPEALS 1 GRANT Him An EXTENSION OF TIME -- UP TO, AND INCLUDING APRIL 27,

21||2020, In Which To File: A PETITION FOR WRIT OF CERTIORARI For The Following

22||Reasons:

23||[1] A REQUEST FOR CERTIFICATE OF APPEALABILITY ("C.O.A.") was Filed to the

24||NINTH CIRCUIT on March 4, 2019. 2 Two (2) NINTH CIRCUIT JUSTICES DENIED the

26||whom is ALLOTTED TO THE NINTH CIRCUIT [IN CALIFORNIA].

1|| "C.O.A. REQUEST" on August 22, 2019. A PETITION FOR REHEARING -- EN BANC was |
2|| Filed to the NINTH CIRCUIT on October 14, 2019. On October 25, 2019, two (2) |
3|| NINTH CIRCUIT JUSTICES DENIED the PETITION FOR REHEARING -- EN BANC. Said |
4|| "DENIAL" was Served to Petitioner "at his Prison" on October 29, 2019. |
5|| Said "Service" occurred "in the evening of the 29th," which was a Tuesday. |
6|| ["AT THIS POINT," PETITIONER WANTS THIS HONORABLE COURT AWARE OF THE FACT THAT |
7|| HE HAS AN ASSISTANT WHOM IS AT ANOTHER PRISON. THIS ASSISTANT HAS BEEN THE |
8|| "SOLE COMPOSER" OF ALL OF PETITIONER'S LITIGATION -- WITH ONE EXCEPTION. THIS |
9|| "EXTENSION REQUEST" IS BEING DRAFTED BY PETITIONER'S ASSISTANT. A DECLARATION |
10|| BY PETITIONER'S ASSISTANT IS FORTHCOMING. HIS NAME "AND INFORMATION IS:" JAMES |
11|| BRADLEY HAAG -- CALIFORNIA INSTITUTION FOR MEN -- EAST -- T-75535 -- DEL NORTE |
12|| 133-U -- P.O. BOX 500 -- CHINO -- CALIFORNIA -- 91708-0500. THIS ASSISTANT |
13|| WILL BE FORMULATING THE "TOTAL CERTIORARI PETITION"]. |
14|| Petitioner mailed the NINTH CIRCUIT "DENIAL" and a "cover letter" to his |
15|| Assistant on November 3, 2019, "in the evening." [It is an important point for |
16|| THIS HONORABLE COURT to know that "regular Prison Mail is picked up at |
17|| approximately 9:45 P.M., Sunday Night through Thursday Night -- only. Such |
18|| mail will be inspected and sealed by "the Graveyard Shift" and subsequently |
19|| delivered to the Prison Mailroom for placement in the United States Mail "in |
20|| the morning." Also, Inmates cannot utilize "Legal Mail Resources." Everything |
21|| between Petitioner and his Assistant is "via Regular Mail"]. For some "unknown |
22|| reason," Petitioner's Assistant WOULD NOT RECEIVE "the November 3 mailings" |
23|| until NOVEMBER 19, 2019. "Back And Forth Mail Times" constitute the "crux of |
24|| Reason [1]" re. this "EXTENSION REQUEST." Timely issuance of "regular mail" in |
25|| Prison "is not a given."

26|| [2] DECLARATION OF PETITIONER'S ASSISTANT

27|| I, James Bradley Haag, am Petitioner, Rodney Jason Stanley's Assistant. I |
28|| am an Uncertified Paralegal. I am not "anywhere close to being a Licensed

1||Attorney." However, I am Highly Intelligent, "well studied, and versed in |
2||Federal Law." Accordingly, Under Penalty Of Perjury Under 28 U.S.C. §1746, I |
3||DECLARE THE FOLLOWING: |
4||[a] I have been Assisting Mr. Stanley since November 24, 2014. "With the |
5||exception of one Document to the DISTRICT COURT," I have formulated ALL of his |
6||State and Federal Litigation. This encompasses "the assembly of EXHIBITS / |
7||SUBSTANTIATING EVIDENCE." I have copies OF EVERYTHING 'ever Filed to any |
8||Court.' "Accordingly, the paper Documents have amassed to approximately a 7 |
9||inch thick stack." I need to be able to review ALL of these Materials because |
10||there are Items that are absolutely essential that this Honorable Court NEEDS |
11||TO SEE when the CERTIORARI PETITION gets submitted. I need time to carefully |
12||Review EVERYTHING -- then subsequently "assemble APPENDICES. "HARD EVIDENCE" |
13||EXISTS "AND IS ON HAND" THAT FULLY "MEETS ALL REQUISITE LEGAL STANDARDS" THAT |
14||SHOWS THAT AN INNOCENT MAN WAS WRONGFULLY CONVICTED DUE TO FLAGRANT PERJURY |
15||"AND OTHER MISCONDUCT" THAT THIS HONORABLE COURT HAS LONG HELD TO BE |
16||UNACCEPTABLE. Mr. Stanley has "a Life Sentence." I need to be certain that ALL |
17||SUBSTANTIATING EVIDENCE is provided to this Honorable Court. I need time to |
18||"properly assemble" these Items and to also be sure that "all APPENDICES" |
19||comport with this Honorable Court's Rules (which I have the 2019 Publication |
20||of). The remainder of an Innocent Man's Life "is on the line," and I need to |
21||be certain that all that I prepare is COMPLETE AND CORRECT; |
22||[b] "Mail time" is a substantial factor. From 'the Postmark on the Envelope, |
23||an average of eight (8) days expires before I receive ANYTHING from Mr. |
24||Stanley.' "There has been many times" that A MINIMUM OF TWO (2) WEEKS HAVE |
25||EXPIRED BEFORE MR. STANLEY HAS RECEIVED "FINISHED PRODUCT" FROM ME. On several |
26||occasions, over 5 weeks expired from the time that I was Issued Materials that |
27||were mailed to me UNTIL MR. STANLEY RECEIVED "MY WORK," was able to make his |
28||requisite copies, then 'submit all to Prison Staff for mailing.' E.G.: I sent |

1||Mr. Stanley "a letter of Instruction pertaining to CERTIORARI Preparation." |
2||One such "Instruction" consisted of me telling him to 'answer the questions in |
3||the IN FORMA PAUPERIS APPLICATION so that I could "type in" the Correct |
4||Information. He went to his Institution's Law Library, got a 2014 "CERTIORARI |
5||PACKAGE," filled out the "I.F.P. Application," and mailed such to me. THAT |
6||MATTER took nearly 4 weeks before I received those Items. In sum, "a round |
7||trip mailing" between Mr. Stanley and Myself is going to average 20 days. For |
8||one final example: Suppose that this Honorable Court receives this "EXTENSION |
9||REQUEST" on January 13, 2020, and there is an error. If a "Correction Notice" |
10||was mailed to Mr. Stanley on January 14 with a 30-day Correction ORDER, it |
11||would take a miracle for him to Receive the ORDER, mail it to me, for me "to |
12||do as ORDERED, mail the "finished product" back to Mr. Stanley, and for him to |
13||get a Law Library Appointment, make requisite copies, and submit said Items to |
14||Prison Staff for Placement In The United States Mail within that 30-day time |
15||frame. "Mail Travel And Issuance Time" would account for approximately 80% of |
16||that 30 days. I have "a tremendous amount of work to do on Mr. Stanley's |
17||CERTIORARI PETITION AND SUPPORTING DOCUMENTS / APPENDICES. I need time to make |
18||sure that my work is complete, correct, and timely. I cannot do so within "the |
19||original 90 days." I had already lost "a bunch of those days" when I first |
20||Received the "Final Ninth Circuit DENIAL" (which is attached); and, |
21||[c] Mr. Stanley is Indigent. Therefore, this EXTENSION REQUEST encompasses the |
22||completion of the IN FORMA PAUPERIS APPLICATION that is included with the |
23||CERTIORARI PETITION and per SUPREME COURT RULE 39. [It should be noted that |
24||Mr. Stanley has been On-Record as Indigent and allowed to Proceed In Forma |
25||Pauperis IN ALL previous State And Federal Proceedings].
