ORDER

These cases come before the court on defendant-appellant's motion: (1) to stay the briefing schedule; (2) to file a supporting record *instanter*; (3) to amend the improperly authenticated record.

On October 29, 2018, this court entered an order stating in part:

"The October 16, 2018 motion for extension of time to file bystanders' reports is GRANTED IN PART. All bystanders' reports for this appeal shall be due November 27, 2018, along with the supplemental record noted in paragraph 2 of this order. This is a FINAL extension for appellant to file both the bystanders' reports and the record. The finality of this extension shall not be affected by appellant's inability to obtain approval from the circuit court for particular bystanders' reports. The appeal will proceed without those reports if necessary, as the court finds that sufficient time will have been provided to prepare and obtain those reports."

On November 30, 2018, this court entered an order granting an extension of time for the appellant to file a brief and indicated that the extension (until December 31, 2018) was FINAL. On January 3, 2019, this court entered an order granting another extension (until January 25, 2019), only because the court was unable to resolve a pending motion for consolidation until January 3, 2019. Again, this court indicated that the extension was FINAL. The notice of appeal in this case was filed on October 10, 2017—over 15 months ago.

Additionally, the record as to which the appellant raises issues of accuracy was filed in appeal no. 1-17-2705 on May 25, 2018, and adopted as the record in appeal no. 1-17-2460 on October 29, 2018. The court finds that sufficient time has long passed for appellant to work with the Clerk of the Circuit Court to address the issues raised in her current motions.

This court hereby ORDERS:

1. On the court's own motion, these consolidated appeals are DISMISSED for want of prosecution. All other pending motions are DENIED as moot.


ORDER


This case comes before the court on appellant's "Motion to Reconsider Referring to Denial ~~of~~ the Unopposed Motion to Stay Proceedings Pending Final Disposition of Case No. 124636, and Then Dismissal for Want of Prosecution". On June 11, 2019, this court entered an order dismissing the case for want of prosecution after the appellant had missed several deadlines for filing her brief. Under Ill. Sup. Ct. R. 367(a), a petition for rehearing from the DWP order was due 21 days after June 11, which was July 2, 2019. The pending motion was electronically filed on July 3, 2019. The clerk has provided this court with a copy of a communication from appellant asserting that she attempted to electronically file the motion before midnight on July 2 but could not because it was "frozen". 
