COMES NOW, Petitioner bringing forth this MOTION AND REQUEST FOR PERMISSION OF LEAVE OF COURT on the _____ day of February 2020, to exceed 15 pages for my "Petition For Rehearing" due to "unregistered foreign agent" Nancy E. Brasel and white nationalist David T. schultz engaging in a racist conspiracy to treat me like a slave in the United States in violation of the Third Ku Klux Klan Act of 1891, United States Constitution, Thirteenth Amendment, the United States Constitution, Fourteenth Amendment, Section 5, and conspiring to cover up or conceal criminal conflicts of interest for the United States Secretary of Treasury, Steven Terner Mnuchin who is a "Silent Partner" to Warner Bros. Entertainment Inc. citing 18 U.S.C. 2(a)(b), 18 U.S.C. 4, 18 U.S.C. 951(a), 22 U.S.C. §§ 611 et. seq., 22 U.S.C. 612 et seq., 22 U.S.C. § 618 et seq., 28 U.S.C. 455(5)(ii), SECTION 2 Sherman Act, 15 U.S.C. § 2, 50 U.S.C. 1712, 50 U.S.C. § 1708(2)(B)(i), Chapter 3, Title 50 U.S.C. 23, 50 U.S.C. § 3021(h), Minn. Secretary of Treasury Steven Terner Mnuchin, U.S. Department of Treasury¹ is a "Silent Partner"² while in "Federal Service" and has a "direct financial interest" in the form of an "Agreement with Warner Brothers" valued at **\$25,000,000.00**,³ a second "agreement with Warner Bros in the amount of **\$1,000,000.00**.⁴ Silent Partner Mnuchin conspired to conceal his guile to bribe unregistered foreign agent Nancy E.
