

COMES NOW Genet McCann and requests an extension of time within which to file her Petition for a Writ of Certiorari pursuant to United States Supreme Court Rule 13. Ms. McCann intends to file a Petition for Writ of Certiorari to seek review and reversal of the Montana Supreme Court's Order entered on December 17, 2019 in Cause No. OP 19-0718, entitled *Genet McCann v. The Twentieth Judicial District Court, in and for Lake County, District Court Judge James A. Manley, presiding*, based upon the Federal Constitutional violations contained therein. Pursuant to United States Supreme Court Rule 13, the Petition is due ninety days from December 17, 2019 which falls on March 16, 2020. Also pursuant to Rule 13, this Application to Extend Time to File Petition is properly filed at least ten days before the date the Petition is due.

JURISDICTION

This Court has jurisdiction under 28 U.S.C. §1254(1).

JUDGMENT TO BE REVIEWED

The judgment to be reviewed is the Montana Supreme Court's Order filed in OP 19-0718 on December 17, 2019 which is attached.

REASON FOR EXTENSION

Ms. McCann respectfully requests under Rule 13, an extension of 60 days within which to file a Petition for a Writ of Certiorari. Ms. McCann has been


diligently pursuing this on-going federal constitutional matter through the Montana state courts and in the related civil RICO case now before the United States Court of Appeals for the Ninth Circuit. However, the filing of three deadlines before these three Courts fall one on the same due date and the third within six days of the other two. The Petition for Writ of Certiorari is presently due upon March 16, 2020. The opening brief of the underlying state court conservatorship case (DG 14-2/14-3) on appeal in DA 20-0021, is also presently due upon March 16, 2020, and, finally, Ms. McCann is currently drafting an opening brief in the closely-related civil RICO case before the United States Court of Appeals for the Ninth Circuit, in Cause No. 19-35730, that is due on March 22, 2020.

The grave injustices due to the issuance, and affirmance, of two *ex parte* orders that intentionally and corruptly block the due administration of another pending state court probate proceeding, before a different district judge, in cause no. DP 19-47, plainly strikes against the fundamental bedrock guarantees of the Federal Constitutions. Hazel-Atlas Glass Co. v. Hartford-Empire Co., 322 U.S. 238, 246 (1944) ("[T]ampering with the administration of justice (sic) involves far more than an injury to a single litigant. It is a wrong against the institutions set up to protect and safeguard the public, institutions in which fraud cannot complacently be tolerated consistently with the good order of society.").

In accord, Ms. McCann respectfully requests a 60 day extension within

which to file her Petition for Writ of Certiorari in this matter.


