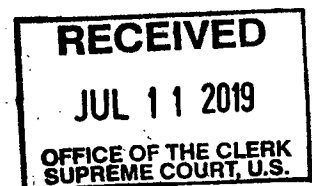
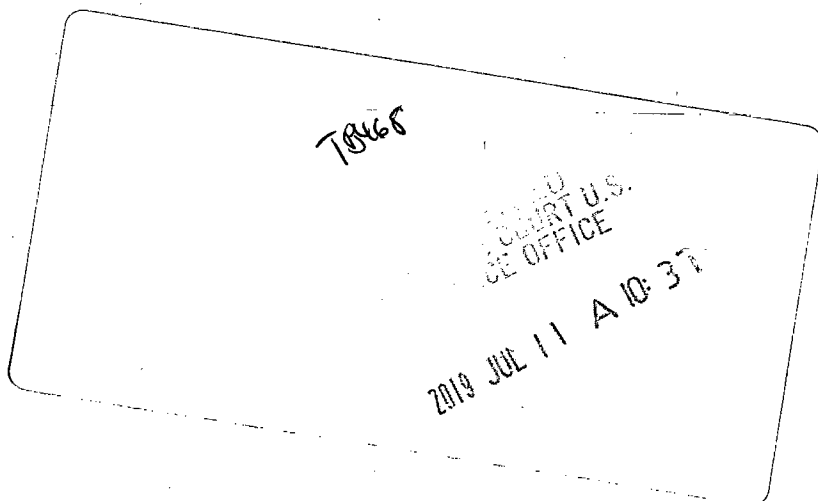

The district court did not abuse its discretion in dismissing the complaint for failure to provide "a short and plain statement of the claim showing that the pleader is entitled to relief." Fed. R. Civ. P. 8(a)(2); see Atherton v. D.C. Office of Mayor, 567 F.3d 672, 681 (D.C. Cir. 2009) (explaining that a "complaint must give the defendants notice of the claims and the grounds upon which they rest").
