MOTION TO IMMEDIATELY FILE BRIEF OUT OT TIME

1. Background, The appellee's brief was due on April 17, 2019, and that day has passed. The appellee, Battles, has received one prior extension of time to file the brief.
2. Authority, Supreme Court Rule 5.02
3. Reasons, As of, during the month of February 2018, plaintiff, Battles was notified for a briefing within the Third Circuit of Appeals at the Eastern Pennsylvania District of the United States Federal Court. However, **[ON JULY 14, 2018, BATTLES; THROUGH AN UNKNOWN SOURCE]** appellee was falsely committed at Albert Einstein Medical Center, Levy 9, 5501 Old York Road, Philadelphia, PA. Battles was held there, without even having the right to testify at Albert Einstein Mental Court. Plaintiff was not discharged until **July 28, 2018. For this when the [falsified 303 complaint was filed by Psychiatrist Musurini. HOWEVER, KNOWING THE BRIEFING HAD TO BE FILED IN A TIMELY MANNER, BATTLES WAS FALSELY RECOMMITTED ON August 12, 2018 and not discharged until August 29, 2018 (going through the same procedure of refused to be allowed to testify at Albert Einstein Mental Court.
