

**MOTION TO IMMEDIATELY FILE BRIEF OUT OF TIME**  
[missed deadline by one day])

1. *Background.* The appellee's brief was due on December 9, 2019, and that day has passed. The appellee is proceeding pro se and has asked for and received one prior extension of time to file the brief.
2. *Authority.* 28 U.S. Code § 2101 [I think]
3. *Reasons.* [The appellee was unaware that the 90 days started on the day of the notice vs. the following day. Therefore, the Appellee missed the deadline by one day [i.e., December 9, 2019 (due date) vs December 10, 2019 (date package was delivered)].
