Dear Mr. Harris:

Pursuant to the Court's March 19, 2020 order, petitioners respectfully request that the Court delay distribution of the petition for a writ of certiorari (and other briefs) until April 27, 2021, for consideration at the Court's conference on May 13, 2021. The petition for a writ of certiorari was filed on January 29, 2021, and placed on the Court's docket on February 3, 2021. After the Court granted one 30-day extension, respondents' brief in opposition was filed on April 2, 2021. Pursuant to Supreme Court Rule 15.5, absent the requested delay, the petition, brief in opposition, and reply brief would be distributed on April 21, 2021, also for consideration at the May 13 conference. Accordingly, delay in distribution to April 27 would not delay the Court's consideration of the petition.

Counsel for petitioners seeks a 6-day extension due to the restrictions currently being experienced because of COVID-19 combined with the press of other litigation deadlines, unanticipated but urgent developments in other matters and the passing of founding partner, Bob F. Wright (1932-2021).

Counsel for respondents have been contacted and do not object to this extension.
