Petitioner does state that:

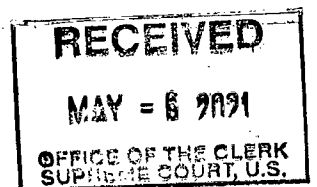
1. he is a prisoner.
