JUDGMENT ENTRY ADOPTING MAGISTRATE'S DECISION

BROWN, J.

On July 25, 2019, this Court granted the Motion for Default Judgment filed by Plaintiff Carline Maria Curry. In said Entry, the Court found that Defendant Douglas MacKenzie—a patent attorney—had been duly served with Summons and a copy of Plaintiff's Complaint in accordance with law. The Court further found that, pursuant to Civ.R. 55(A), Defendant is in default for failure to Answer or otherwise respond to Plaintiff's Complaint within the time period provided by Civ.R. 12, and, resultantly, Defendant has thereby confessed the allegations in Plaintiff's Complaint to be true.

Although the Court granted Plaintiff's Motion for Default Judgment, the Court's Entry did not resolve this matter in its entirety. The Court granted default judgment in Plaintiff's favor on the issue of liability only, finding that the amount of damages Plaintiff is entitled to recover could not be determined solely from the pleadings and other documents filed in this case. Therefore, the July 25, 2019 Entry granting Plaintiff's Motion for Default Judgment includes an Order of Reference and Notice of Damages Hearing.

Pursuant to the Order of Reference, Magistrate Pamela B. Browning conducted a damages



whether or not the Defendant is in military service and showing facts to support the affidavit" required under the Servicemembers Civil Relief Act. 50 U.S.C. 3931(b)(1)(A).

Based upon the foregoing, the Court finds Plaintiff's Motions for Default Judgment and Motions to Certify Service by Publication is Complete not well-taken and hereby **DENIED**. The Court notes that Plaintiff appeared in this matter for a pre-trial conference on February 12, 2019, at which time it detailed the instant ruling to Plaintiff, noting that nothing in this Entry shall preclude re-filing a Motion for Default Judgment should Plaintiff undertake the proper steps to effectuate service upon Defendant and include the aforementioned military-status affidavit. That same day, Plaintiff filed with the Clerk a request for service via ordinary mail, and on February 13, 2019, the Clerk issued a certificate evidencing the February 12, 2019 mailing. Thus, pursuant to Civ.R. 4.6(D), Defendant's answer day was 28 days from February 12, 2019.
