





The title was previously securitized by Countrywide Home Loans and recorded by MERS under the ownership of the seller, Roberto Chaidez Jr. Bank of America purchased this asset & failed to pay off investors. By December 2007, the title was securitized and the investors were named as "Certificate Holders of Banc of America Funding Corporation Mortgage Pass Through Certificates, Series 2007-5."

8. At closing on May 16, 2007, Endencia paid for 2006 real estate taxes continuously until 2013. Elements of 735 ILCS 5/13-109

- a) Hostile claim - numerous investors own the mortgage. Endencia owns unsecured note.
- b) Actual possession - Endencia managed tenants, paid utilities & lived at 235 S Hale St Addison IL and continuously paid real estate taxes since purchase.
- c) Open possession - Endencia rented out units, collected their rent, made improvements on property, paid utility bills and lived there.

9. On December 14-16, 2015, ex Sheriff John Zaruba exerted control and took possession of the property and Endencia's personal & business belongings. He misrepresented to Endencia that he was looking for other persons in building. He brought with him numerous individuals and was joined by Endencia's visitor, Ed Reeve of 216 Sophia Street

West Chicago IL 60185. Phone No (630) 650 9550.

He promoted looting. He did not secure Endencia'a personal belongings. They had access to her phone book with passwords to various agencies, bank safe keys and information, veterinary drugs. They aggressively stole what they could, including cashing out her daughter's education savings (worth at least \$1,000), retirement funds, utilized and did not pay utility bills in a timely manner, stole 3 original paintings and coin collection at bank safe at First Midwest Bank located 2601 West Schaumburg Road, Schaumburg IL 60194.

Petitioner Frances contacted Addison Police but they could not stop the eviction /theft.

In pursuant to 735 ILCS 5/9 101, Forcible Entry is prohibited. Ex Sheriff John Zaruba utilized the color of the law and made misrepresentations of searching

other persons in the building to Frances Endencia, as she was leaving for work. He and his companions failed to produce an enforceable eviction order.

In pursuant to 735 ILCS 5/9 - 102 (a) (1), (2), Endencia is entitled to repossession of real estate and her personal and business property.

735 ILCS 5/12-168 states " Return - Liability. The officer making such sale shall, in his or her return of the certified copy of the judgment particularly describe the goods sold, and the sum for which each article was sold; and if he or she is guilty of fraud in the sale or return, he or she shall be liable, in a civil action to the party damaged, for 5 times the amount of the actual damage sustained by reason of such fraud.

Ex DuPage Sheriff did not possess a judgment order

to take Endencia's belongings and promote looting.

He has not provided Endencia with description of what was taken and sold.

7. Wells Fargo provided Mario & Leticia Arce a "Special Warranty Deed" in 2016 without recording the purchase price paid to the investors of Banc of America certificate holders 2007-5 or to Wells Fargo / Bank of America to the DuPage County recorder's office.

WHEREFORE, Dr Frances Endencia respectfully prays for an order:

a) That the special warranty deed given by Wells Fargo, as Trustee for the Certificate Holders of Banc of America Funding Corporation Mortgage Pass Through Certificates, Series 2007-5 to Mario & Leticia Arce be void. In pursuant to 735 ILCS 5/9

102 (a) (2), the possession of Mario & Leticia Arce is unlawful since they did not have a valid enforceable eviction order. The DuPage County records do not show any payment made to the investors of Bank of America Certificate Holders 2007-5 or to Wells Fargo, their agent.

b) That a clean title be given to Petitioner Frances Endencia, and her daughter, Altessia as the only owners of 235 S Hale St Addison IL 60101. Any and all foreclosures be dismissed

c) Eviction order of Mario & Leticia Arce & unknown tenants.


d) In pursuant to 735 ILCS 5/12-168, it states: Return - Liability. The officer making such sale shall, in his or her return of the certified copy of
