I, Keith L Arnold, Petitioner, hereby file this Petition for Rehearing Petition for Writ of Certiorari (corrected).

To further its harassing me, without coming to my door with any prior warning or notice, the City of Auburn gave me another parking ticket and sticker on Jan 12, 2021 while I was restricting nonessential travel during COVID-19 [Exhibits 1 and 2]. I was at home but no one came to my door, I happened to look out and see a cop but he left, so he put the ticket and sticker on my car before I looked out.

Per my Motion to File, my Petition for Writ of Certiorari (corrected) was stamped received JAN 4 2021 by your court but was returned to me with a letter dated January 15, 2021 and my check stating the reason was the order of the Washington Court of Appeals No. 80246-1-1 dated October 10, 2019 was not included. A copy of that order was in the appendix as page "A-v". Also, it was listed in the APPENDIX TABLE OF CONTENT as page "A-v" which was in the petition on page "iii" and at the beginning of the APPENDIX. Your letter gave no other specific correction to make.

My Petition on page 24 states. "The appellate court's denying my Motion to Modify on Martin Luther King's actual birthday of January 15, 2020 is a blatant racist message adding and/or highlighting racism to its defiance, abuse, and coverup."

The U.S. supreme court incorrectly returning
