Dear Mr. Harris:

The petition for writ of certiorari in this matter was filed on March 15, 2021, and subsequently docketed with a specified response date of April 29, 2021. Respondent filed a waiver of response on April 6, 2021, and on May 12, 2021, the Court requested that a response be filed. Respondent's response is presently due June 11, 2021.

Respondent has not previously sought an extension, and pursuant to Supreme Court Rule 30.4, Respondent respectfully requests a 30-day extension of time to file his response up to and including July 12, 2021, as July 11, 2021 falls on a Sunday.

This extension is necessary because undersigned counsel requires more time to review the record in this matter and respond to the petition. Counsel is filing an amicus curiae brief in a Ninth Circuit expedited preliminary injunction appeal with a due date of June 10, 2021. (*LA Alliance for Human Rights, et al. v. County of Los Angeles, et al.*, Case No. 21-55395.) Since our firm is still working remotely, preparing and filing two substantive appellate pleadings on the same timeline is extremely difficult, and the additional time is necessary to allow counsel to prepare a response that will aid the Court in
