Dear Mr. Harris:

On September 2, 2021, this Court granted the parties' joint motion to remove this case from the oral argument calendar and hold further briefing in abeyance in light of an agreement in principle to settle this putative class action.¹ We write to provide an update to the Court regarding the status of settlement proceedings.

On January 13, 2022, the plaintiffs-respondents filed their motion for preliminary approval of the settlement with the Superior Court. On August 2, 2022, the Superior Court issued an order granting preliminary approval of the parties' settlement. As we reported in our August 22, 2022 update, the final settlement approval hearing is scheduled for December 1, 2022. We do not believe further action by this Court is warranted at this time. We will provide another update in 45 days.
