The complaint in this action seeks a "[t] rial with  
god's law" and to" prevent insult and unfair behavior."

The complaint also makes various religious statement that are not correlated with any alleged conduct by defendants Northwell Health and Long Island Medical Center (Defendants). he court notes that Plaintiff Xiu Jian Sun, who refers to himself as the Spiritual Adam, as wall as The Church of Jesus Christ of Latter-day saints Servant, has brought similar in Nassau County and federal court.

Pursuant to the "So-ordered" transcript (Court Reporter, Deborah Salzman), it is

ORDERED that defendants' Northwell Health and Long Island Medical Center' s (Respondents). oral application to dismiss the complaint with prejudice is granted; and it is further

ORDERED that Plaintiff is precluded from commencing any actions in New York Country purporting to represent the interests of The Church of Jesus Christ of Latter-day saints.

This result is required by three factors. First, Plaintiff has no standing to act on behalf of nominal plaintiff The Church of Jesus Christ of Latter-day saints. Plaintiff presents no evidence that he has authority to represent the Church of Jesus Christ of Latter-day saints. Second, the complaint fails to state a cause of action that may by the subject of a judicial

determination. Instead, it invokes religious exhortations. Third, plaintiff 's claims cannot be challenged in a judicial setting, as said claims are purported to come from "A Higher power."

This is not belittle or belie the veracity or sincerity of plaintiff 's claims, it is just to say the court lacks both personal and subject matter jurisdiction over said claims.
