I hereby certify that on this 10th day of June, 2021, I served three copies of the "Petition for Writ of Certiorari to the Supreme Court of Virginia" on each of the following Respondents and Attorney General of Virginia by certified, first-class mail or hand delivery. However, I am a bit confused about the actual attorneys for the Respondents. In the FCCC, the Prosecutor for the County of Fairfax was Maureen E. Cummings, VSB # 85680. The FCCC Judge *sua sponte* changed the name of that case in his 1/15/2019 "Final Order" from County of Fairfax v. Mercer to Commonwealth of Virginia v. Mercer. Thereafter, neither the **County of Fairfax** nor the **Commonwealth of Virginia** appeared in the COAV to oppose me. In the SCV, there was a Brief in Opposition filed by an Assistant Commonwealth Attorney, Office of the Fairfax County Commonwealth Attorney with an e-mail address @fairfaxcounty.gov but her name (C. M. Jackson) appears above only "*Counsel for Appellee Commonwealth of Virginia.*" [A183-184]. I am going to be cautious here and assume Prosecutor Maureen E. Cummings still represents the **County of Fairfax** but never appeared in the COAV nor SCV and Assistant Commonwealth Attorney (in the Office of the Fairfax County Commonwealth Attorney) C. M. Jackson represents only the **Commonwealth of Virginia**. In the meantime, I will e-mail C. M. Jackson to try to figure this out.
