

The Court reviews all pleadings in the above cause, including Petitioner's Petition for Writ of Habeas Corpus, the Suggestions in support thereof, Reply and Response.

A Scotland County jury found Barnes guilty of four counts of first-degree statutory sodomy and one count of first-degree child molestation, and the court sentenced him to four concurrent terms of life imprisonment and ten years' imprisonment in the Missouri Department of Corrections. Barnes serves these sentences at SECC. Warden Jason Lewis is the respondent.

The Court further reviews the applicable law and cases cited by the Petitioner and Respondant. Having been fully advised, and it appearing that Petitioner is not entitled to a Writ of Habeas Corpus, the relief requested in said Petition is DENIED.
