We represent respondents Timothy D. Laurent and Smeeta Sharon in the above-referenced matter, which was docketed July 16, 2020. We write, pursuant to Supreme Court Rule 30.4, to request a 30-day extension of time in which to file Respondents' brief in opposition to the pending petition for certiorari. The brief in opposition is currently due August 17, 2020. The requested extension would make the brief due September 16, 2020.
