

## **QUESTIONS FOR PETITION FOR REHEARING**

1. In the middle of the night on November 15, 2020, did Myers receive divine intervention elevating and encouraging onward Myers's work on this matter, and then replicated on December 7, 2020, and even December 11, 2020 emphasizing the meaning of life and urging Myers in a loving sense?
2. Are there other sufficiently intervening matters, pertaining to health, life, family and children which have arisen since the filing of the Petition, on or about September 15, 2020?
3. Is Myers raising imperative issues, vital to the spiritual health and well-being of America, which have not been adequately understood? In that respect, does this very Petition provide an opportunity for opening the gateway to healing the American spirit?

## DISCUSSION

### Introduction

Now nearing twenty-five years of work, perseverance and struggle on this situation, Myers has continually embraced a deep spiritual sense of this particular journey; indeed, he has declared this a Biblical level story. This case cannot be confined, to merely existing law and practice, because it is unto itself a ground-breaking case, societally, if not meritoriously legally. This case, and the backdrop to it, shreds open the societal understanding of emotional/psychological abuse, and the capacity to conduct this heinous behavior for "decades."<sup>1</sup>

The challenge in this situation is clearly to depict it poignantly because, as hard as it is to understand, Myers does not know everything, but knows that the standard of the Tort for the Intentional Infliction of Emotional Distress of an "average member of a community being moved to exclaim: "Outrageous!" will be met and exceeded, when the reader correctly comprehends the horror of what is transpiring. In that Myers has in God's world, in our universe and highest of highs, called the Honorable Supreme Court an intermediary court, under the realms of love, life and truth itself, Myers proceeds with his sense of intervening events, since November 16, 2020, the date of this Honorable Court's denial of Myers's petition.

## **QUESTIONS: DREAMS, DIVINE INTERVENTION AND LOVING ENCOURAGEMENT**

With the utmost love and respect, Myers sees the Honorable Supreme Court as the highest of our cherished American legal system, and still only intermediary with respect to the ideals themselves, of truth, liberty, and justice. It is a cautionary sense, a pause if you will for all of us, because if we honestly believe that we, as women and men are the highest powers than there can be tendencies for our other occasionally adverse human tendencies to creep into the picture may arise. These tendencies include, but are not limited to: arrogance, over believe in our importance, and even vindictiveness.

Humans acting with any sense of higher power, be it God, the universe, source, or something can be like breaks with no brake pads or a car, or perhaps even without breaks themselves. Myers surely does not consider himself exempt from such encouragements and admonishments. Given the uniquely solitary nature of Myers's epic twenty-five-year journey; he has on occasion experienced extremely strong dreams which serve as a wake-up call, correction, or guideposts for Myers. On such incident occurred in the morning of November 15, 2020, partially in response to Myers' further reading of how the court itself handles Petitions for Writ of Certiorari. Reading for instance, a quote from a law clerk circulating on the internet: "That I never approved one petition..." or words to that effect underscored

the challenge, if not a certain reality of Myers's petition brought to conference on November 13, 2020 and DENIED on November 16, 2020.

The net effect of Myers's dream of that date was to encourage Myers onward and to do so in a loving sense. In using that word, Myers cannot help but to note the synchronicity of his usage of that word and the legendary story of Richard and Mildred Loving brought before this Honorable Court, and how it pertained so much to the basic rights of human beings. Myers sees his life and work, this Petition as an act of love. Perhaps it is his greatest challenge, no matter how deeply Myers has been battered by life and this situation, to proceed forward and to do so in a loving fashion. No matter, how deep the indignity Myers has suffered, in his previous petitions and filings, Myers accepts it as his responsibility to response in a loving fashion towards his family, courts and America.

In bringing forth the notion that this is a Biblical level story, acknowledged I part by the Massachusetts Appeals Court, Myers sees the "vile"<sup>2</sup> abuse he has suffered as the rich soil, in which to reshape his life and thoughts over a twenty-five-year period. To the degree, Myers emerges like a butterfly from a cocoon; that butterfly in Myers' mind is to educate and teach, potentially heal, and surely not react in anger, as anything less than a loving response, might doom his message.<sup>3</sup> So, it is patently in a loving sense, as excellently as possible encompassing his own human imperfections that Myers brings forth his advocacy, firmly convinced of his

stumbling and/or being pushed into a morass of his own families' and America's moral morass, and firmly steps forward to insist upon and influence positive change in these areas.

### **ANOTHER DREAM: DECEMBER 7, 2020: The SOUL OF SAMUEL MORRIS MYERS AND THE RIGHTS OF A PARENT TO BE A PARENT**

Substantively related, another dream occurred on the morning of December 7, 2020, which highlighted some events from Myers' familial past in Cambridge, MA, and emphasized his son Samuel Morris Myers "Sam" (DOB May 22, 1993). Myers legally has leaned towards emphasizing Sam perhaps a tiny bit more than his daughter Sophia Rose Myers "Sophie" (DOB March 17, 1990) because Sophie was three years ahead of Sam when this turmoil broke out intensively around 2002, and seemingly slightly more removed from the direct battle itself.

For whatever reason, Sophie and Sam, have since, their births been seen in rather special lights, as really all children deserve on some level. Still, their very existence seems to have set off a frenzy of obsession with being involved with their lives and showcasing themselves to Sophie and Sam, by a plethora of extended family members. Perversely following some of the thinking from Nathan Myers (Myers's younger brother and antagonist of the initial Petition) and Stolzenberg (Nathan Myers's wife), by their actions and not their words, other people have more right to be involved with Myers's children, than Myers himself, even if not especially after Sophie and Sam's mother ("Carney") died on or around February 1, 2016.

Any responsible parent knows the lengths they would go for their own child or children. Focusing less on the psychological perversion in play, that would afford others the opportunity to need to be significant in someone else's children lives, and more of the sense of soul of Sam for one, in this case. Myers has again historically had a profound relationship with Sophie and Sam, that in its roots is about learning and having a positive moral presence in this world. Not only has that been adversely threatened and interrupted over the past eighteen years intensively<sup>4</sup> and Sophie and Sam been filled with tons of hateful, pejorative, and false thoughts towards Myers, but missing is the positive sense of what Myers offers as a parent.

The dream of December 7, 2020 brought home to Myers the soul of Sam, and in essence the reason(s) why Myers accepted this fight/challenge in the first place. Myers is sincerely advocating for the life, heart and soul of his own child. No one, else in this situation can make that statement of direct relationship, not his family, not lawyers, and not even the Supreme Court. Sam has a gentle soul, one which Myers in his empathic educational sense recognizes. What greater honor is there, then to care for, work for, and even appropriately fight for, if need be, the life and well-being of his old child.

Not, the crassness of some of today's actions, but the heart of Myers's work as a father is what he represents, not for something foreign, for his own child. Not even generally, but specifically for a heart, a soul, a gentleness of his son, and daughter that perhaps only a parent can recognize. Myers has not even seen Sam, in nearing

nine years, under extremely false pretenses, fathom the harm to Sam, to some degree Sophie and to Myers.

It is worth noting that America arose, with much revulsion as we saw the plight of children at the border. We do not remotely have a collective understanding of the horror we are doing to our naturally born American children, in the horrors of American divorce. We are horrifically separating children, from parents regularly, and it must stop. Courts would often not know the children involved if they walked right past them on the street.

**A FINAL DREAM: December 11, 2020: A DREAM TO MOVE MYERS**

**TO ACTUALLY SUBMITTING THIS PETITION**

This very morning, Myers had a dream of driving while committing an infraction and being pulled over. Myers again, saw this dream as a reminder to proceed in a loving sense, arresting any anger, and inspiring Myers to proceed with this petition.

**QUESTION TWO: HAVE ISSUES WITH MYERS LIFE, PARTICULARLY HEALTH EMERGED, WHICH AMPLIFY MYERS'S ADVOCACY?**

The main thing is that since November 16, 2020, Myers has been going through ongoing screening and tests pertaining to an unfathomably severe pain in his leg. There is some chance this is a cancer of some kind, which as of this date, December 11, 2020, a biopsy has been ordered for next week. It is not that Myers appeals to this Honorable Court solely based on sympathy, although a tad of

empathy, never hurt, lol; it is a function of a few other things: 1) There is potentially an increased poignancy to Myers's words, that he is representing a fundamental truth that needs to be heard and understood for him, courts, and America; 2) Myers in essence does not want to leave anything out of his effort. Through the past twenty-five years, there has clearly been a sense of a divine mission, where Myers has been pushed into casting aside, some of the everyday societal concerns, and truly giving everything, he has to this work. At times, Myers has put health, and other everyday concerns on the backburner. Even more, in way the emotional pain, Myers has also minimized for the cause, is significant, and may take on physical manifestations at this point. 3) Myers put his advocacy into actions, not just words, and while he still holds a vision of living a long and happy life, if that were not the case, Myers would have few regrets, given the richness of this fight, work and advocacy over the past twenty-five years.

### **QUESTION THREE: PERHAPS WITH ADDITIONAL MATURITY ON MYERS' PART IS THERE A POIGNANCY TO MYERS'S MESSAGE THAT IS RELEVANT TO TODAY'S AMERICAN MINDSET?**

Given questions one and two, and Myers' response is there indeed a divine message for America, in terms of recalibrating to its true message and spirit. The cornerstone of Myers's life and work, exhibited through this advocacy, is that it is our goodness, which forms a greater strength<sup>5</sup> than crassness, and cheap shot

tactics, which for one, in this instance Myers attributes to the couple of Nathan Myers and Stolzenberg. Beyond this situation, Myers sees that there needs be a shift in the American mindset, towards that basic goodness.

Of all things, Myers takes that sense of potentially engendering that shift


