The petition for a writ of certiorari in the above-captioned case was filed on October 7, 2020, and placed on the docket on October 8, 2020. The Mayor and City Council of Baltimore's response is due on November 9, 2020.

We respectfully request, under Rule 30.4 of the rules of this Court, an extension of time to and including December 9, 2020, within which to file the Mayor and City Council of Baltimore's response.
