MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*


The petitioner asks Leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.

I, Curtis Wiggins, am the petitioner in the above-entitled case. In support of my motion to proceed in forma pauperis, I state that because of my poverty I am unable to pay the costs of this case or to give security therefor; and I believe I am entitled to redress.

In the following sources during the last 12 months, *no* money has been received.

(1) I have been and is currently unemployed, since May 1, 2018. (2) My Marital Status: single (3) I own *no* assets, stocks, bonds, car(s), and etc. (4) No money or cash in a checking or savings account (5) No real estate, stock, bond, security, trust, jewelry, art work, or other financial instrument or thing of value, owned (car, house), including any item of value held in someone else's name; (6) No housing, utilities, or loan payments, or other regular monthly expenses (temporarily, staying with a friend who is in bankruptcy); (7) There are no persons dependent on me for support, my relationship with each person, and how much I contribute to their support; (8) \$758.00 dollars in debts or financial obligations to collection agencies: *IC System*, and *Mercantile Adjustment BU*. 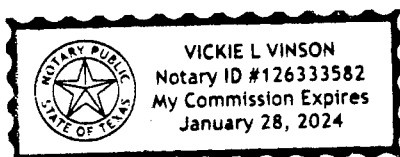


