**AFFIDAVIT OR DECLARATION
IN SUPPORT OF MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***

I, Friedrich Lu, am the petitioner in the above-entitled case. In support of my motion to proceed *in forma pauperis*, I state that because of my poverty I am unable to pay the costs of this case; and I believe I am entitled to relief.

I have never been married and have no dependents or children. The amount of money received by me from each of the following sources during the past 12 months are all zero: employment, self-employment, income from real property (such as rental income), interest and dividends, gifts, alimony, child support, retirement (such as social security, pensions, annuities, insurance), disability (such as social security, insurance payments), unemployment payments, public assistance (such as welfare), and others.

I have not been employed for the past two years.

I do not have cash, an account in a bank or any other financial institution.

I own no assets (such as home, other real estate, motor vehicle).

No person, business, or organizations owed me anything.

No persons rely on me for support.

My estimation of average monthly expenses of myself is almost zero, eating and sleeping in a homeless shelter -- specifically expenses for rent or home-mortgage payment; utilities; home maintenance; food; clothing; laundry and dry-cleaning; medical and dental expenses; recreation, entertainment, newspapers, magazines; insurance (homeowner's or renter's; life; health; motor vehicle; or other); taxes; installment payments (for motor vehicles, credit card, department store or other); alimony, maintenance, and support paid to others; regular expenses for operation of business, profession or farm. Use of mass transportation (\$90 a month) is financed by debts.

I do not expect any major changes to my monthly income, expenses or in my assets or liabilities during the next 12 months.

I have not paid -- or will be paying -- an attorney (or anyone other than an attorney) any money for service in connection with this case, including the completion of this form.

I declare under penalty of perjury that the foregoing is true and correct.
