

ORDER

On May 20, 2019, an order of appeal was entered, granting the appellants, Angela Rogers and Edgar Rogers, an appeal from the judgment of the trial court rendered in open court on May 16, 2019. The May 16, 2019 judgment, memorialized in a signed judgment on May 29, 2019, denied the appellants' "Motion to Proceed IFP on Appeal of January 11, 2016 Judgment."

Under La. C.C.P. art. 1841, a judgment that determines the merits in whole or in part is a final judgment. Under La. C.C.P. art. 1915, certain types of partial final judgments are immediately appealable or may be certified for immediate appeal. The denial of a motion to proceed *in forma pauperis* is an interlocutory judgment. It is not a final judgment under La. C.C.P. arts. 1841 or 1915(A), nor is it a judgment subject to being designated as final pursuant to La. C.C.P. art. 1915(B). As such, the denial of the appellants' motion to proceed *in forma pauperis* is not an appealable judgment, despite the trial court's granting of the motion for devolutive appeal.

It is within this Court's discretion to convert the improper appeal to an application for supervisory writ. La. Const. art. V, § 10(A); *Stelluto v. Stelluto*, 05-74 (La. 6/29/05), 914 So. 2d 34. Accordingly, the appeal is hereby converted to a writ and will be reviewed under this Court's supervisory jurisdiction when briefing is complete.

The appellants, Angela Rogers and Edgar Rogers, also filed a motion to supplement the record, requesting a "complete record" of the trial court proceedings be supplemented into the record on appeal. A review of the record shows that it is complete for review of the denial of appellants' "Motion to Proceed IFP on Appeal of January 11, 2016 Judgment." Accordingly, the appellants' motion to supplement is hereby denied.
