BY THE COURT:

This appeal is DISMISSED, *sua sponte*, for lack of jurisdiction. Marco Manuel Torres appeals from the magistrate judge's decisions directing the district court clerk to return his filings. Because a magistrate judge's decisions are not final and appealable orders until rendered final by a district court, we lack jurisdiction to entertain this appeal. *See* 28 U.S.C. §§ 636(b)-(c) & 1291; *United States v. Renfro*, 620 F.2d 497, 500 (5th Cir. 1980); *Donovan v. Sarasota Concrete Co.*, 693 F.2d 1061, 1066-67 (11th Cir. 1982) (explaining that a magistrate's actions while proceeding under § 636(b) "are not final orders and may not be appealed until rendered final by a district court.").

No motion for reconsideration may be filed unless it complies with the timing and other requirements of 11th Cir. R. 27-2 and all other applicable rules.


