This firm represents respondent The Methodist University, Inc. (“Methodist”) in the above-captioned case. Petitioner Tammy Horton (“Horton”) filed her Petition for Writ of Certiorari on July 23, 2020 and the matter was placed on the docket on August 10, 2020. Therefore, pursuant to Rule 15.3 of the Rules of the Supreme Court of the United States (the “Rules”), Methodist’s brief in opposition to Horton’s Petition for Writ of Certiorari is currently due on September 9, 2020.
